A dvocates for Children of New Jersey each year publishes *New Jersey Kids Count*, a report about the well-being of children across the state. While statewide data are helpful in tracking overall trends, it is also useful to go beyond state averages and look closer at the range of experiences of children living in different parts of the state. The *New Jersey Kids Count Pocket Guide* measures how children are faring in each of New Jersey's 21 counties.

Although this year's data once again reveal different conditions for child well-being in each county, rising child poverty persisted in all but five counties — Cape May, Hunterdon, Passaic, Sussex and Mercer — from 2009 to 2013. With a 56 percent decrease, Hunterdon saw the steepest decline in the number of children living in poverty, followed by Sussex at 35 percent, Cape May at 21 percent, Passaic at 4 percent and Mercer at 2 percent.

In all the other counties, the number of children living in families earning too little to meet their children's needs increased, ranging from a low of 3 percent in Monmouth and Union counties to a high of 97 percent in Salem. Statewide, the number of children living in families earning below the federal poverty line rose 22 percent during that same time.

Unemployment, however, continues to drop, decreasing 41 percent from 2010 to 2014 statewide. All but one county — Cape May – experienced declines in unemployment, with many seeing substantial drops. This may help improve the state's child poverty numbers in the coming years. The latest data for child poverty is one year behind unemployment figures.

Other key trends:

School breakfast. New Jersey schools continue to make strong progress in feeding more low-income students school breakfast, with every single county achieving increases in the number of children who receive this healthy start to the day. Somerset led the counties on this front with a 181 percent increase, followed by Hudson at 171 percent. This is likely due, in large part, to more districts serving "breakfast after the bell" over the past year. This approach significantly increases student participation. Essex had the smallest increase at 8 percent.

Introduction

Uninsured Children. While the number of uninsured New Jersey children continues to decline statewide, some counties are seeing sharp increases – a worrisome trend. At 71 percent, Sussex had the highest increase in the number of uninsured children from 2009 to 2013. During that time, the county's uninsured rate nearly doubled from 4 to 7.6 percent of all Sussex County children. Five other counties also saw concerning double-digit increases, including Hunterdon at 58 percent and Cumberland at 45 percent. Despite this increase, the number of children enrolled in NJ FamilyCare, the state's free- or low-cost health insurance, rose in every county from 2010 to 2014. It is possible that this could have a positive impact on the uninsured data for 2014, which has yet to be released.

Child Abuse. The number of children who were found to be victims of abuse or neglect jumped 29 percent from 2009 to 2013. This is probably due, at least in part, to a change in the system state investigators now use to determine if child abuse has, in fact, occurred. In 2013, New Jersey added an "established" category that means abuse did occur, but the child was not seriously harmed and there were mitigating factors, such as a parent being under tremendous stress.

The established finding carries fewer long-term ramifications for people who are found to have abused or neglected their children. Previously, investigators could only "substantiate" a report of suspected abuse or neglect or find it "unfounded." A substantiated finding is still made in more serious cases of child abuse or neglect. A substantiated finding puts a person on a child abuse registry, essentially, for life, making it nearly impossible for them to be approved as a caregiver for a relative's child who may need to enter foster care or work in many jobs that involve children.

Child Care Costs. An average New Jersey family with one infant and one preschooler in licensed child care spent about a quarter of their income on that care in 2013. Atlantic County parents paid the highest portion of median family income on child care at 38 percent, while Hunterdon parents spent the smallest portion at 18 percent. National standards say families should spend no more than 10 percent of income on child care.

In addition to this pocket guide, Advocates for Children of New Jersey ranks each county on a set of 13 indicators of child well-being. This year, seven counties improved in the Kids Count rankings, six dropped and eight remained the same. Following is a summary of the changes and the overall rankings for each county.
